• Horizon was awarded \$1,991,554M, for a Homelessness Grant over a 5-year period. <u>Crisis Receiving Center (CRC) Update</u>

 Melissa spoke with Mary Begor, DBHDS Crisis Services Coordinator and discussed another possible proposal option. Instead of presenting another proposal Melissa suggested giving Horizon startup funds. Ms. Begor is taking Melissa's request under advisement and looking at the state level for funding. All of Horizon's billable items have been accounted for in the original proposal and Horizon is only asking for costs associated with the CRC. Melissa reported that Horizon is looking for a 20K square foot building to renovate or to purchase land to build to suit. Melissa will give another update at the September meeting.
